



### SIGNING OF MEMORANDUM OF UNDERSTANDING BETWEEN LEMHANNAS RI AND BPK RI



Governor of Lemhannas RI Prof. DR. Muladi, S.H. signs a Memorandum of Understanding (MoU) with BPK RI on the cooperation for the development and management of Information Systems for Data Access in Auditorium Building of BPK RI.

The provision of transparent and accountable information relating to responsibility for and management of state finance is one of the obligations of any institution managing state budget. It is a part of their primary duties and functions whose limitations are established according to laws and regulations.

State Audit Agency of the Republic of Indonesia (BPK RI), as a state institution in charge of auditing the management and accountability of state finance, has made a strategic step to enter into a Memorandum of Understanding (MoU) with the National Resilience Institute, the Ministry of Industry, the National Resilience Board, the State Intelligence Agency, and the National Standardization Agency on the development and management of Information Systems for Data Access. The signing of the MoU, which was held on Thursday,

December 23, 2010 at the Auditorium Building of BPK RI, is aimed at establishing a cooperation relationship for the development and management of Information Systems for Data Access. Therefore, it is expected to facilitate the auditing of the management and accountability of state finance. The MoU shall be treated by Lemhannas RI as trust from BPK RI for Lemhannas RI to meet the needs for electronic information on Lemhannas RI's financial management.

With the signing of the MoU, Lemhannas RI has an obligation to implement it with full responsibility. Therefore, Governor of Lemhannas RI Prof. DR. Muladi S.H. expects a coordination with BPK RI as well as guidance by BPK RI, both in terms of auditing and coordination meetings, so that the Memorandum of Understanding can be implemented effectively and efficiently.

**A** Forum Group Discussion organized by the Coordinating Ministry for Political, Legal and Security Affairs with the theme of “Involvement of TNI and Society Components in Handling Terrorism within the Unitary State of Indonesia” at the Coordinating Ministry for Political, Legal and Security Affairs on December 2, 2010.

Acting a resource person, Governor of Lemhannas RI Prof. DR. Muladi, S.H. gave a presentation on the theme of “Legality and Synergy (TNI-Police) of the Use of Armed Forces in Handling/Cracking Down the Actions of Terrorists, Militants or Other Armed Radical Groups in the Perspective of Integrated and Comprehensive National Security.” In his presentation, the Governor of Lemhannas RI said that the reform movement in 1998 has reaffirmed the values or basic principles of constitutional democracy, such as checks and balances, transparency principle, transparent, accountable and responsive governance, law supremacy, regional autonomy, freedom of the

press, promotion and protection of human rights, development of civil society as well as principle of civilian control over the military.

The democratic principles are affirmed explicitly and implicitly in the 1945 Constitution of the Republic of Indonesia and other laws and regulations that are enacted in the reform era, as in Article 30 point (3) of the 1945 Constitution, MPR Decree No. VI/MPR/2000 on the Separation of Military and Police. On the occasion, Lemhannas RI recommended that the materials of Law No. 23/PRP/1959 on the State of Emergency be amended with improvements adjusted for current conditions, and be included in imminent Law on National Security. Lemhannas RI even deemed it necessary to include disaster-emergency condition and immediate establishment of National Security Council (DKN), which will be led directly by president. DKN will expectedly serve as a forum to help or give advice to the president in making various policies related to national security.

The chairman of the US-China Economic Security Review Commission (USCC) delegation, accompanied by nine members of the delegation, paid a courtesy call to the Governor of Lemhannas RI, Prof. DR. Muladi, S.H. on December 17, 2010 at the governor's office.

In the courtesy call, Governor of Lemhannas RI, Prof. DR. Muladi, S.H. was accompanied by Expert Lecturer in the Field of Diplomacy, Air Vice Marshal Surya Dharma, S.I.P and Head of Public Relations Bureau Brigadier-General TNI Irwan Kusnadi, S. Sos, M. Sc, as well as Head of Cooperation Brigadier-General TNI Danu Nawawi, S.Sos.

In the courtesy call, apart from discussing Lemhannas RI and USCC, some issues related to security and economy were also discussed. Governor of Lemhannas RI conveyed that the United States should regard Indonesia as a country to be reckoned with amid an increasingly dominant position of China, either in terms of economy or politics. Therefore, as the world's largest democracies, Indonesia and the United States should continue to forge and enhance cooperation in various fields, especially in security and economy.

Governor of Lemhannas RI expected that the United States can provide assistance in primary weaponry defense system and capacity building, which are needed by Indonesia -- as an archipelagic country -- to secure the integrity of its territory. On the other hand, the United States also expected Indonesia and ASEAN countries to unite and work together in resisting threats that can disrupt the democracy that has been going well so far.

**MOTHER'S DAY CELEBRATION:****"EQUALITY BETWEEN WOMEN AND MEN IN NATIONAL CHARACTER BUILDING TO BUILD A HEALTHY AND DIGNIFIED COMMUNITY"**

The commemoration of the Mother's Day, which is held annually on December 22, seeks to continue to remind us all of the struggle of women, along with men, in seizing the nation's independence. The pledge made by freedom fighters on the first Indonesian Women's Congress (KPI) on December 22, 1928 in Yogyakarta was a milestone in the history of women struggle. At the third Women's Congress in 1938, December 22 was determined as a Mother's Day. Further, the Indonesian government, guided by Presidential Decree No. 316 of 1959 on national days that are not holidays, determined the Mother's Day on December 22 as a national day that would be celebrated annually by the Indonesian people.

On December 22, 2010 Lemhannas RI held a ceremony commemorating the 82nd Mother's Day which was attended by all members of Lemhannas RI. Over the past 82 years, there has been much progress made by Indonesian women in their role and dedication, either as subject or object of development. The Indonesian women have been active in various areas of development as agents of change. They are able to sit in strategic positions and enjoy the fruits of development together with men in all parts of Indonesia.

The commemoration of the Mother's Day had the theme of "Equality between Women and Men in National Character Building to Build a Healthy and Dignified Community". Acting as an Inspector of the Ceremony, Inspector General of Police Moch. Rasyid Ridho, S.H., M.H. read the speech of State Minister of Women Empowerment and Child Protection. It was conveyed that the meaning of the theme of the Mother's Day are values of equality between women and men. Those values are the basis for the formation of moral character in order to love homeland and nation, hold fast to nationalism and nationalistic viewpoint.

In line with that, the efforts to form the national character through education should start early from the family, and then continued to school and community. Appreciation and tolerance towards pluralism need to be promoted and strengthened as part of national character building. As for the word "healthy" that was included in the theme, it showed that, without health, it is not possible for our nation to carry out development as well as to support the realization of one of the Millennium Development Goals in health in 2015. The development of women empowerment, in order that they are equal with men, requires improved coordination, synergy and integration, both among ministries/agencies, ministries/agencies with regional governments and all relevant stakeholders. In order for the struggle that we have been going through does not go in vain, or even to make it stronger in the future, we must hold fast to four basic pillars of our nationhood, namely Pancasila, the 1945 Constitution, the Unitary State of Republic of Indonesia and Unity in Diversity.

**H**ead of General Affairs of Lemhannas RI Brigadier-General of Police DR. H. M. Said Saile, M.Si. opened a ceremony of job orientation, which will last for 5 days, for probationary civil servants of Lemhannas RI 2010 on January 3, 2011 in Astagatra Building Fl. III East. The event was also attended by Head of Personnel Division Captain (K) Nurheryanto, S.E., Head of Administration Division Ir. Ita Endah Pratiwi, M.A., Head of Domestic Affairs Division Col. Inf Endang Nirwan, as well as other officials from the Bureau of General Affairs of the Main Secretariat of Lemhannas RI.

The job orientation is intended to provide an overview to all probationary civil servants – numbering to 20 -- in Lemhannas RI on the organizational structure, main tasks and functions of Lemhannas RI as well as the rights and obligations of civil servants as state apparatus before they receive their assignments according to their respective competence. Therefore, they are expected to be able to respond to and meet formational needs of Lemhannas RI. The job orientation is an early stage of development for the probationary civil servants of Lemhannas RI before they move to the next level of career development, such as pre-service training and others.

The head of bureau of general affairs in his speech expressed his expectation to the participants that they carry out the whole series of job orientation activities as best as they can. They are also encouraged to develop and improve themselves in every execution of tasks in their respective work units by holding onto Prasetya Panca Korpri, which is a code of conduct of civil servants that must be followed and implemented at every execution of duty. This code of conduct requires loyalty and obedience to the Unitary State of the Republic of Indonesia and the 1945 Constitution. This should not just be mere pledge but proved with evidence, so that the honor of the nation and state as well as professional confidentiality and state secrecy remain maintained. ## SIGNING OF MEMORANDUM OF UNDERSTANDING BETWEEN LEMHANNAS RI AND JAKARTA PROVINCIAL ADMINISTRATION ON THE RENOVATION LEMHANNAS RI'S BUILDINGS

On Wednesday, January 12, 2011 a Memorandum of Understanding was signed between Lemhannas RI and the Provincial Administration of Special Capital Territory of Jakarta on the renovation of Lemhannas RI buildings at Nusantara Room I, Trigatra Building, Lemhannas RI.

The MoU was signed by the two parties involved, namely Governor of Lemhannas RI Prof. DR. Muladi, S.H. as the first party, and Governor of the Province of Jakarta Capital Special Region DR. Ing. Fauzi Bowo as the second party. Acting as witnesses were Deputy Attorney General for Civil and State Administration of the Attorney General's Office, Kamal Sofyan Nasution, S.H., M.H., and Vice President Director of PT. Construction Manggala Pratama, TBK., Ir. Sutopo Kristanto, M.M.

The construction of the buildings of Jakarta Provincial Administration, which has been ongoing since 2010, has resulted in the damaged infrastructure of Lemhannas RI. Both parties have agreed that the damage will be borne by the Jakarta Provincial Administration.

With the MoU, a concrete follow-up is expected for immediate renovation of Lemhannas RI's buildings under the provisions agreed upon by both parties.

Governor of Lemhannas RI Prof. DR. Muladi, S.H. expected that the renovation of Lemhannas RI's buildings would be undertaken through enduring architectural and structural improvements meeting safety, security and comfort standards.

# MEETING BETWEEN GOVERNOR OF LEMHANNAS RI AND ADHOC TEAM OF LABKURTANNAS WITH UKP4

**G**overnor of Lemhannas RI Prof. DR. Muladi, S.H. and Adhoc Team of the National Resilience Measurement Laboratory (Labkurtannas) held a meeting with the Head of the Presidential Working Unit for Supervision and Management of Development (UKP4) Prof. Dr. Ir. Kuntoro on January 12, 2010 at Labkurtannas meeting room, Astagatra Building, Fl. 8 of Lemhannas RI.

In a speech delivered by the Governor of Lemhannas RI, it was conveyed that the capacity and quality in the implementation of primary tasks and functions of Lemhannas RI are currently being strengthened. In order to support the success of the program, Lemhannas RI is undertaking bureaucratic reform and institutional revitalization based on high technology/Information Communication Technology (ICT).

Seven areas that will be revitalized are e-Office, e-Procurement, e-Learning, e-Library, e-Evaluation, Capacity Building Improvement, and National Resilience Measurement Laboratory (Labkurtannas).

Labkurtannas was developed since 2007 with the function to develop a measurement system of national resilience and simulation model that will be able to monitor and analyze national resilience and national resilience in the regions, as well as to predict the impact of public policy on national resilience.

Until now, Indonesia has not had a comprehensive information system that can be used to detect the impact of strategic environmental dynamics and public policy on national resilience. Therefore, Lemhannas RI, in line with its duties and functions, is obliged to build an information system involving many experts and stakeholders from outside of Lemhannas RI. Furthermore, it also involves relevant institutions from 33 provinces throughout Indonesia for system development and data filling.

Governor of Lemhannas RI also said that the measurement and simulation results will later be compiled in a profile book on the national resilience and national resilience in the regions. Currently, one profile book on national resilience and 33 profile books on national resilience in the regions (provinces) have been produced.

# THE HANDOVER CEREMONY OF PERFORMANCE STANDARDIZATION REPORT OF LEMHANNAS RI

**T**he Governor of Lemhannas RI, Prof. DR. Muladi, S.H. led the Handover Ceremony of Performance Standardization Report of Lemhannas RI year 2011 on January 13th of 2011. On his speech, Governor said the absorption of 2010 budget had increased compared to 2009 budget, but it still needed comprehensive evaluation and improvement, including in the accuracy of planning.

The purpose of Performance Standardization is to create effective, transparent, and accountable government management so that clean and trustable system can be created. Performance accountability is every unit obligation of government institution to make themselves accountable for the implementation of program and budget. According to the President Instruction No 7 of 1999, every work unit has obligation to make a Report on Accountability and Performance of Government Institutions (LAKIP).

The goal is to make Lemhannas RI an accountable and transparent government institution, transparency, increase program and budgeting participation, and also to maintain credibility of Lemhannas RI. Lemhannas RI's 2009 LAKIP had been increased significantly, it has rise from the rank 70 to 15 of 74 government institution which is assessed by the Ministry for State Apparatus Empowerment and Bureaucratic Reform. By this event, Governor expected the accountability of Lemhannas RI will increase Governor delivered his message in his speech, specifically:

**First**, as far as possible avoid crash programs which can impact to the program implementation and planned budget.

**Second**, every work unit asked to obey the program implementation schedule and budgeting schedule appropriate with SKEP/01/I/2011 January 3rd 2011.

**Third**, the accuracy of implementation activities is an important point for the Ministry of Finance to asses the accuracy of planning of Lemhannas RI.

**Fourth**, work unit that has priority program but has not been included in Budget Implementation Entry (DIPA) 2011 is suggested to propose the program again for the 2012 budget planning.

**Fifth**, to maximize the coordination, consultation, and assistance in the implementation of program and budget.

**Sixth**, program and budgeting 2011 can be applied with sincerity, open heart, and avoidance of individual interests that can undermine this institution. We hope the unqualified opinion predicate and other achievements can be maintained in Lemhannas RI.

**Seventh**, in relation to 2012 budget, every work unit has to refer to, in the implementation of program and budget, strategic planning (Renstra) of 2010-2014, vision and mission of Lemhannas RI as well as strategic development.
