

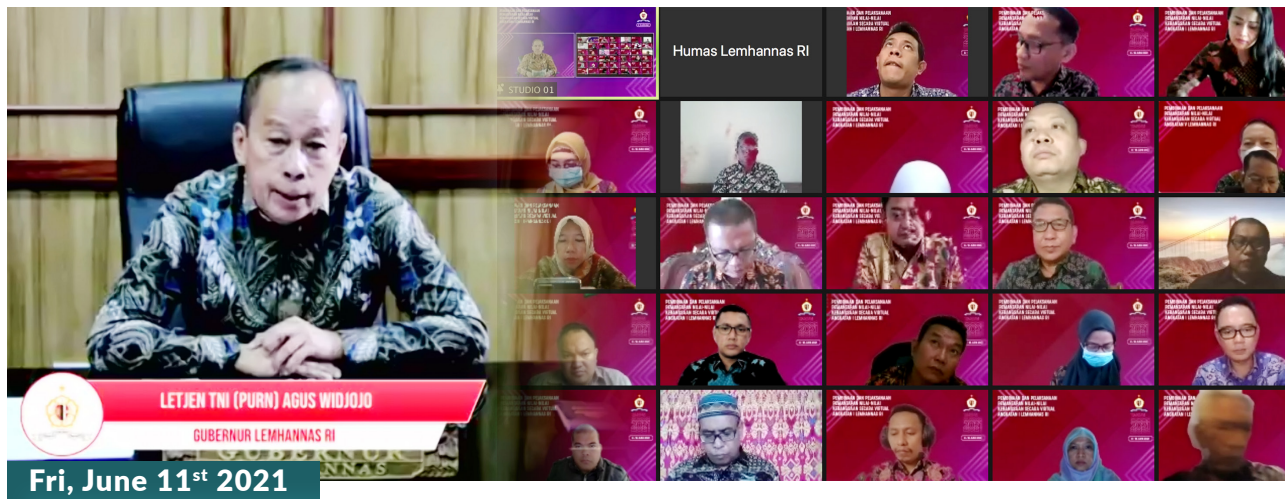

Lemhannas RI's Wins of WTP Opinion



The Governor's Introductory Speech to the Participants of Virtual Taplai Batch I

The Governor of Lemhannas RI, Lieut. Gen. (Ret.) Agus Widjojo made a leader's introductory speech to the participants of the virtual program of Strengthening National Values Batch I of Lemhannas RI, on Friday (11/6) online.

Starting his speech, Agus stated that national resilience refers to a condition in which the nation has strength from endurance in the context of achieving national goals. Agus then explained that to achieve national goals, the state must face threats, disturbances, obstacles, and challenges which can be overcome if the state has excellent national resilience.

Agus emphasized that national resilience is built through five approaches, namely ideological, political, economic, sociocultural, as well as defense and security approaches. Each approach will affect the condition of national resilience and if one of the aspects is in unhealthy condition it will affect the overall national resilience condition. To build each approach, the associated discipline is required. For example, economic approach will require the discipline of economics studied at the Faculty of Economics.

Furthermore, Agus explained that the condition of national

resilience is also built through a geographical spatial approach, namely the resilience condition of each province. The condition of national resilience can be considered good if the resilience condition of all provinces is good. However, it is indisputable that when building provincial resilience, an approach is needed. In addition to the five approaches and geographical spatial approaches, the other three approaches including geography, demography, and natural resources must also be used as a basis to build national resilience

In achieving good national resilience, public policies formulated by leaders are needed. In this case, a leader must possess knowledge in formulating policies and competencies in formulating and implementing policies effectively. Agus also said that Indonesia is a democratic country. Therefore, it is acceptable to have different views and democracy also guarantees freedom of expression. However, all opinions and ideas must come from the Basic Consensus of the Nation and must aim to strengthen the Basic Consensus of the Nation, namely Pancasila, the 1945 Constitution of the Republic of Indonesia, the Unitary State of the Republic of Indonesia, and Bhinneka Tunggal Ika.

According to Agus, if freedom of expression is misused by compiling an idea that originates from other than the Basic Consensus of the Nation or has aims other than the Basic Consensus of the Nation, then this freedom should be doubted. "All differences in opinion and ideas must come from the same source and have the same goal; must come from the Basic Consensus of the Nation and aim to strengthen the Basic Consensus of the Nation." Agus stated.

Launch of the Implementation of Presidential Regulation No. 7 of 2021 concerning RAN PE

Deputy Governor of Lemhannas RI, Air Marshal Wiekto Syofyan representing the Governor of Lemhannas RI, attended the Launch of the Implementation of Presidential Regulation No. 7 of 2021 concerning the National Action Plan for the Prevention and Countermeasure Against Violent-Based Extremism Leading to Terrorism (RAN PE) 2020-2024, on Wednesday (16/6), online.

The event was opened with the keynote speech from the Vice President of the Republic of Indonesia, Prof. Dr. (H.C) K.H. Ma'ruf Amin. "I hope that this launch will

strengthen the commitment of all relevant parties to carry out their duties and responsibilities perfectly," the Vice President stated.

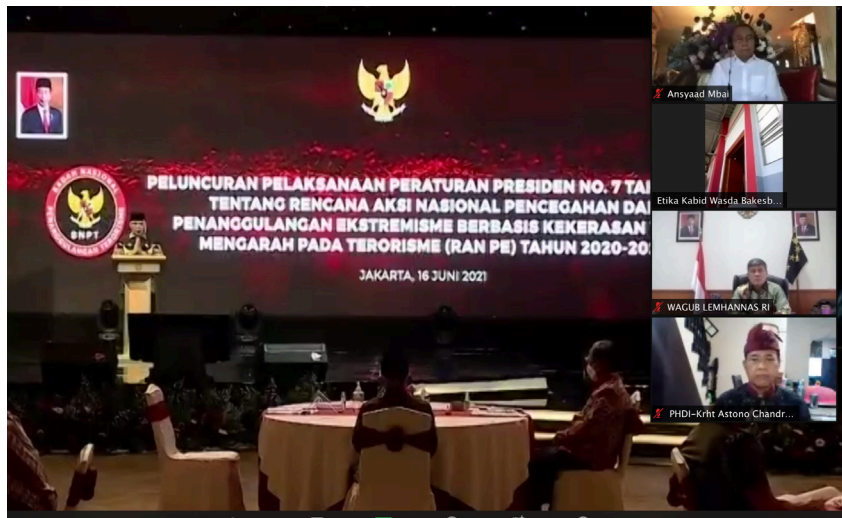
Furthermore, the Vice President said that currently, Indonesia is facing the threat of intolerance, radicalism, and extremism, which have resulted in the emergence of countless violence-based incidents. This evidently poses as a security disturbance in people's lives, and can threaten ideology and the life system of the nation and state. "We must always be vigilant and must keep trying to prevent and overcome attitudes that show intolerance, radicalism, and extremism," the Vice President emphasized.

Furthermore, the Vice President said that the Preamble of the 1945 Constitution of the Republic of Indonesia stated that the Indonesian government was established to protect the whole nation. The purpose of the RAN-PE is to strengthen the protection of the citizens' rights of security from violent extremism that leads to terrorism as part of the state's implementation of human rights in order to maintain national security stability based on Pancasila and the 1945 Constitution of the Republic of Indonesia.

"I expect RAN-PE to be implemented with a comprehensive strategy to ensure the systematic, planned, measured, and integrated steps using collaborative and inclusive work from all parties," the Vice President continued.

On this occasion, the Vice President conveyed messages to various parties. To the ministers and leaders of related institutions, they are responsible for the implementation of RAN PE in accordance with their respective authorities through the support of adequate activities and budget. To the governors, regents, and mayors as leaders who directly associate with the community, they are responsible to ensure that RAN PE is implemented in their respective regions.

Especially to BNPT as the leading sector in implementing RAN PE, it is expected to properly coordinate, monitor, and evaluate the implementation of RAN PE. To all community leaders, educational leaders, religious leaders and community organizations as one of the determinants of the success and implementation of RAN PE, they are expected to cooperate and actively participate in every effort to prevent and overcome violent extremism that leads to terrorism.

Integration and Trial of National Resilience Measurement with Regency/City Database

Head of the Laboratory Center (Kapuslab) of Lemhannas RI, First Marshal Suroto, S.T., M.A.P., along with his staff carried out the Integration and Trial of National Resilience Measurement with Regency/City Database, on Wednesday (16/6) in North Kalimantan Province.

The National Resilience Index Measurement and Provincial Data Integration with Regency/City Bases included a series of development actions of national resilience measurement system that had been designed since 2015 for all provinces in Indonesia.

In the 2021 Fiscal Year, the development of provincial-national resilience measurement system with regency/city bases will be carried out in three provinces, including North Kalimantan, North Sulawesi, and South Sulawesi. Therefore, "National resilience possesses an especially strategic value for ensuring the survival of Indonesia," Suroto said. Furthermore, Suroto stated

that various threats, disturbances, obstacles, and challenges including issues of poverty, unemployment, inequality, separatism, terrorism and radicalism, intolerance, drugs, natural disasters, and the Covid-19 pandemic are pressures that are extremely harmful for the survival of Indonesian nation.

Suroto argued that with the diverse and complex pressures, if the Indonesian nation does not possess powerful resilience, it is possible that the pressures can be potentially harmful for the country causing Indonesia to become a failed state or even a collapse state.

Therefore, the condition of national resilience must always be monitored so that the condition can be maintained to be in the safe and good state. By knowing the condition of national resilience, steps or efforts can be implemented as the strategic anticipation by strengthening certain aspects that are considered weak through national development

programs and national development in regions.

The Integration and Trial of National Resilience Measurement with Regency/City Database is the subsequent stage of a series of collaborative activities in measuring national resilience in North Kalimantan Province with the Laboratory Center of Lemhannas RI, which previously started with dissemination activities in 2020.

Suroto emphasized that the Integration and Trial of National Resilience Measurement with Regency/City Database aims to realize the capability development of the national resilience measurement system application currently owned by Lemhannas RI and at the same time expands its use. "Not only for Lemhannas RI, but also for the Provincial Government of North Kalimantan. It is even hoped that it will reach the Regency/City Government in the Province of North Kalimantan," Suroto said.





Socialization of Archive and Official Letters Management Lemhannas RI

Lemhannas RI held a socialization of archive and management in accordance with the Governor Regulation of Lemhannas RI Number 03 of 2020, on Thursday (17/6), online.

The event was started with the speech delivered by the Head of Legal and Cooperation Bureau of Lemhannas RI, Commodore Sri Widodo, S.T., CHRMP stating that government management refers to a regulation in carrying out tasks and functions in various fields of activity in government agencies in the implementation of good government administration, which must be supported by the good and orderly administration capability.

According to Sri Widodo, one of the important components is general administration, including form management, institutional nomenclature, abbreviations/

acronyms, archives and office layout. Lemhannas RI has issued the Governor Regulation (Pergub) of Lemhannas RI Number 03 of 2020 concerning the Form Management of the National Resilience Institution of the Republic of Indonesia. By implementing this regulation, it is hoped that the regulation and management of official letters, including composing letters, logos, paper sizes/types, characters, authority for signatures and official stamps, can be more organized.

In accordance with this theme, the committee also invited Dra Dwi Mudalsih M.Hum, the associate archivist in the central directorate to carry out the training of archive management at all levels of government within the ministry and institution, both state institutions and non-structural institutions.

Dwi opened the speech by

presenting the Archive Management Legal Basis, namely Law (UU) No. 43 of 2009 Concerning Archives Management, Government Regulation (PP) No. 28 of 2012 Concerning the Implementation of Law No. 43 of 2009 Concerning Archive Management, Regulation of the Head of the National Archives of the Republic of Indonesia (Perka ANRI) No. 2 of 2014 Concerning Guidelines for Form Management which is interrelated to the implementation of the Governor Regulation of Lemhannas RI No. 03 of 2020 Concerning Form Management.

The Governor Regulation refers to the Regulation of the Head of the National Archives of the Republic of Indonesia No. 2 of 2014 Concerning Guidelines for Form Management, so that it serves as a guideline for all state institutions, including central and regional institutions, related to the formulation of form management in each institution. This becomes a national reference that must be a guideline in the formulation of form management in their respective institution.

The scope of the form management of Lemhannas RI in accordance with Governor Regulation No. 3 of 2020 has met the requirements of the legislation which includes 5 categories.

"The type and format of form management is important because it implements the Electronic-Based Dynamic Archive Information System (SRIKANDI). Form management includes letters (characters), letter-making templates, logo usage, ink usage, and other aspects. The regulation of security classification categories includes Very Confidential, Confidential, Orderly, and Ordinary. These classification categories are used as archive form codes. Regulating the access rights is categorized into official form security, related to Official Form Signing and Official Form Control," Dwi said.

Laboratory Center of Lemhannas RI Conducts a Workshop with **Wikasatrian Leadership Training Center**

The Head of Laboratory Center (Kapuslab) of Lemhannas RI, First Marshal Suroto, S.T., M.A.P. along with his staff held a National Leadership Measurement Workshop with the Wikasatrian Leadership Training Center on Tuesday (22/6). At the workshop, Wikasatrian was led directly by the Chief Guardian of Wikasatrian Leadership Center WIKA, Tony Warsono.

The workshop is one of the steps in supporting the main tasks of the Laboratory Center (Puslab) of Lemhannas RI, at which the National Leadership Division (Bidpimnas) of Puslab will develop a static and dynamic system of national leadership measurement.

In the formulation of the leadership measurement, it is necessary to determine the aspects, variables, and indicators that will be used. Therefore, as an effort to enrich and sharpen the concepts of these aspects, variables, and indicators, a National Leadership Measurement

Workshop was held, by collaborating with the Wikasatrian Leadership Training Center.

The Wikasatrian Leadership Training Center was selected because one of its tasks is serving as a place for leadership training using the concept of local wisdom. "We want to obtain data and opinions from Wikasatrian regarding national leadership that has a significant influence in improving national development," Suroto said.

In his presentation, Suroto said that the purpose of the workshop at the Wikasatrian Leadership Training Center was to support the development of a static and dynamic system of national leadership measurement and the formulation of national leadership measurement instruments including formulation of aspects, variables, indicators, and questionnaires.

Furthermore, Suroto conveyed several benefits of national leadership measurement, including producing

objectively and comprehensively measurable and accountable assessment data for national leaders identifying and self-controlling the condition of national leaders, mapping out Pimnas namely which areas were good or otherwise, diagnosing national leadership problems, subjects to correction, evaluation and education of national leaders, supporting research and development of national leaders, realizing good governance and clean government, and strengthening national resilience.

On this occasion, Tony Warsono said that Wikasatrian was presented by PT. Wijaya Karya (Persero) Tbk. for Indonesia with Local Wisdom-Based Leadership Learning. The purpose of the Wikasatrian Leadership Program is to become a center for leadership learning, both internally and externally, to produce effective, inspiring, and encouraging leaders for better Indonesia.

Furthermore, Tony said that the leadership program at Wikasatrian was based on the point of view that the learning participants were subjects who have noble values and strengths that were grown and developed by their own choices. Leaders are expected to produce effective and contributing work from themselves and their organization because they are the guides for Indonesia in using Indonesia's comparative advantage to become the competitive advantage.

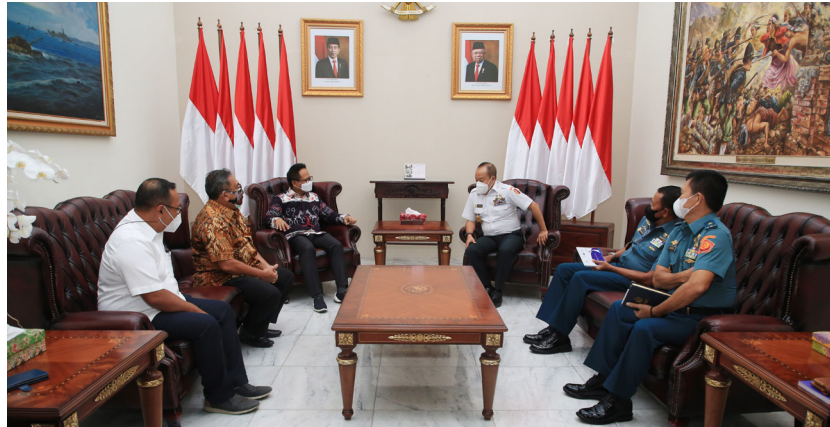
ITB Alumni Have High Interest in Increasing National Outlook Wed, June 23rd 2021

Indonesian Islamic Preacher Coordinating Board's Courtesy Call to Lemhannas RI Thu, July 1st 2021



The Governor of Lemhannas RI, Lieut. Gen. (Ret.) Agus Widjojo welcomed a courtesy call from the Central Executive Board of the Indonesian Islamic Preachers Coordinating Board (PP Bakomubin) officials including the General Chairman of Bakomubin, Dr. H. Ali Mochtar Ngabalin, M.A., the General Secretary of Bakomubin Yayan Surahman, S.T, the Head of Law and Human Rights Fajri Timur S.H., and Regional Coordinator for Java, Bali, NTB, NTT Drs. H. M. Asraf Ali, on Thursday (1/7), in the Governor's Executive Guest Room Lemhannas RI.

In the courtesy call which implemented strict health protocols, the General Chairman of Bakomubin, Dr. H. Ali Mochtar Ngabalin, M.A. said that Bakomubin had recently held a National Working Gathering (Silatnas) last May. The Silatnas discussed several issues, including religious moderation and strengthening the national insight for the preachers.

Therefore, according to Ali, the courtesy call was a follow-up to the issues discussed in the Silatnas in order to provide preachers with archipelago insights. "In the

history of the new republic, there were missionaries who were given National Insights at Lemhannas," said Ali. The strengthening of this insight is intended so that the preachers have qualified insights when conveying messages.

Responding to this, Agus as the Governor of Lemhannas RI welcomed the intention and stated that it was not too late to do so. "This is a challenge for all of us because we know that in the midst of spreading religious teachings with an intolerant consistency, we have to do something. We cannot just sit still and criticize but we have to be able to do something," Agus said.

Agus also conveyed that it was still a challenge of which the results of education and strengthening of insights became concrete forms instead of only jargon. "We, at Lemhannas, have to provide concrete results instead of idealism and normative jargon challenges. We have to produce concrete results. What is expected by the preachers with national insights is our shared challenge," Agus said.

Lemhannas RI's 6th Wins of WTP Opinion

The Governor of Lemhannas RI, Lieut. Gen. (Ret.) Agus Widjojo attended the Submission of the Audit Summary (LHP) on the 2020 Financial Reports of the Ministries/Institutions (LKKL) on Tuesday (29/6), at the Auditorium of the BPK RI.

On this occasion, Agus directly received the LHP on the 2020 LKKL with an Unqualified Opinion (WTP) submitted by Associate I of the BPK as the Head of State Finance Audit I Dr. Hendra Susanto, S.T., M.Eng., M.H., CFA., CSFA. The WTP opinion is the 6th consecutive achievement of

Lemhannas RI since 2015.

In addition to Lemhannas RI, there are eleven other LKKLs under the authority of the Principal Auditorates of State Finance (AKN) I that received WTP Opinion. The eleven LKKLs includes LHP Financial Reports of The Coordinating Ministry for Political, Legal and Security Affairs, The National Security Council (Wantannas), The National Counter Terrorism Agency (BNPT), The Maritime Security Agency (Bakamla), The National Committee of Human Rights (Komnas HAM), The National Cyber and Crypto Agency (BSSN), The Corruption Eradication Commission (KPK), The National Narcotics Agency (BNN), The Meteorological, Climatological, and Geophysical Agency (BMKG), The General Election Supervisory Agency (Bawaslu), and The National Search And Rescue Agency (Basarnas).

In the audit of the twelve LKKLs of 2020, BPK found significant problems related to the Internal Control System (SPI). These problems included inadequate administration and security of inventory and intangible assets, inadequate administration

of utilization and security of state property, inadequate administration and security of evidence and confiscated goods, and inadequate SPI for cash management.

In addition, significant problems were also found related to non-compliance with constitutional regulations, among other including cash management in the expenditure treasury did not fully comply with the provisions; there was realization of income and expenditure outside the APBN mechanism; and the realization of goods and capital expenditures did not comply with the provisions. However, before the LHP is issued, the audited entity has followed up on the recommendations of the audit findings.

"BPK appreciates several work units that have followed up on the findings of the BPK audit while the audit process was still in progress," Hendra Susanto said. BPK appreciates the follow-up that has been carried out and hopes that the Ministries/Institutions can continue to work hard to maintain the opinion in the coming year.

Lemhannas RI Prepares for Jakarta Geopolitical Forum 2021

Lemhannas RI held a virtual coordination meeting for the Jakarta Geopolitical Forum (JGF) 2021 led by the Governor of Lemhannas RI, Lieut. Gen. (Ret.) Agus Widjojo and attended by Gita Wirjawan, MBA., MPA, Dr. Karlina Leksono Supelli, and Tri Agung Kristianto, on Monday (12/7) online.

On this occasion, Gita Wirjawan, MBA., MPA, stated that the JGF 2021 discusses the context of civilization and the separation between the United States and China. In the context of civilization, Chinese civilization is the oldest. Regarding this, to be able to bridge the civilizations of China and the United States, it requires similar age of civilization as China, for example that of Europe and Southeast Asia. Therefore, Gita believes that representatives of the two civilizations are needed to comprehend China's interests and to become a bridge to the United States.

Agreeing with Gita, Dr. Karlina Leksono Supelli said that it is important to recognize the threats that will arise in the future

amid the separation of the United States' relationship with China. On this occasion, Karlina said that civilization is built upon human security. Therefore, it is necessary to focus on which issues that matter. According to Karlina, human development or empowerment needs to be reconsidered and then enclosed with human security and dignity. Karlina also said that the current world structure is characterized by inequality and this condition will certainly affect the human-centered civilization.

Tri Agung Kristianto also agreed with Karlina. According to Kristianto, humans are central. Kristianto also believed that the pandemic has made it clear that culture is growing. However, every person still needs other people, for example, no matter how good a technology expert is, they will still need other people when they are sick. This is a true realization that the culture that is built in the future needs to put humans at the center because humans cannot live alone, unlike machines that can be digitalized.

Meanwhile Agus hoped that the direction of JGF should be clear, so that JGF 2021 has more benefits for future lives instead of only sharing thoughts.



The Governor of Lemhannas RI as a Speaker at the National Service Training of Trainers UPN Veteran

The Governor of Lemhannas RI was present as one of the speakers in the National Service Training of Trainers at the Veterans National Development University on Monday (12/7). Lecturers of the Jakarta Veterans National Development University, Yogyakarta Veterans National Development University, and East Java Veterans National Development University were present to participate in the event.

Starting his presentation, Agus quoted President Joko Widodo's statement that national service has a very broad spectrum. National service can be carried out by every citizen and can be practiced in daily life according to their respective roles and professions.

Furthermore, Agus emphasized that national service has a very

broad spectrum. Therefore, it does not come from a certain Ministry/ Institution because its scope is nationally. However, Agus considers that regarding national service, there still present confusion in conception because of the thought that national service is often perceived as involving military and weaponry.

According to Agus, the function of structuring the national service system has not provided a meaning that can be implemented in a concrete, comprehensive, and final way. "The essence of national service is the attitude and actions of citizens based on love for the country," Agus said.

Agus also believed that all citizens must be encouraged to love the country and be manifested in the willingness to protect, defend, and

promote life together. Awareness of national service is essentially a willingness to serve the country and a willingness to sacrifice to defend the country. "Devotion is showing their best performance in their respective professions," Agus said.

Furthermore, Agus conveyed the basic elements in national service, including loving the country, being aware of the nation and state, believing in Pancasila as the state ideology, willing to sacrifice for the nation and state, and having initial capabilities for defense (this is the forerunner of forming a reserve component). Among the five elements, the four elements are soft power, while the remaining element is military training. "Therefore, military training only serves 20 percent of the formation of initial state defense capabilities," Agus said.

Lemhannas RI held a socialization of raising legal and legislation awareness, on Thursday (15/07) online. The socialization was themed “Governance Policies and Service Policies of the Electronic-Based Government System (SPBE) of Lemhannas RI” and presented a speaker, the Director of PT. Infiniti Putera Omega Muhammad Rahmat Gunawan, S.T., M.T.

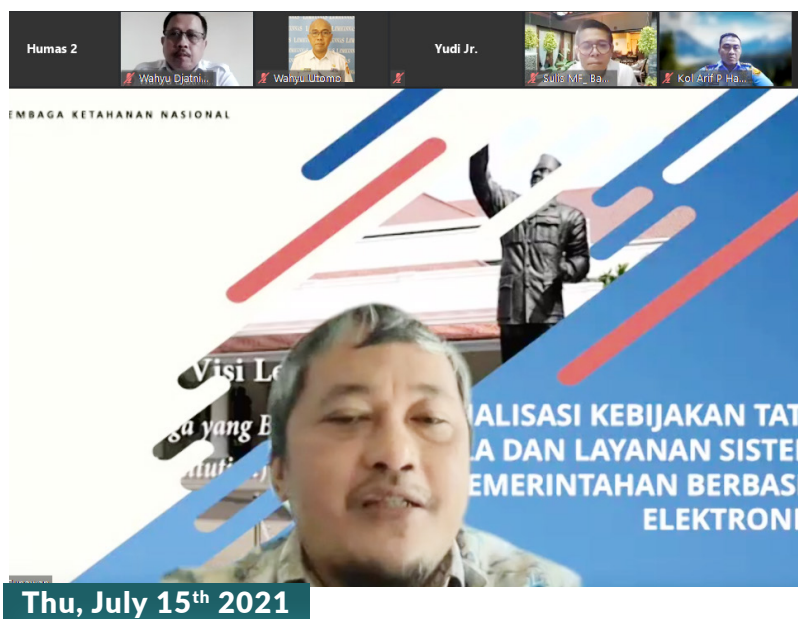
Electronic-Based Government System (SPBE) or better known as E-Government is a government administration that utilizes information and communication technology to provide services to SPBE users. This is stated in the Presidential Regulation of the Republic of Indonesia Number 95 of 2018 concerning Electronic-Based Government System. SPBE aims to realize good governance, to improve the quality of public services, and to increase community participation in the implementation of development.

The Chief of Cooperation and Legal Bureau of Lemhannas RI, Commodore Sri Widodo, S.T., CHRMP opened the socialization event. In his remarks, Sri Widodo explained that the government needs careful preparation to develop Indonesia that is advanced, dignified, competitive, and equal to developed countries in the world. “One of the efforts to support the construction of Good Government is through the implementation of E-Government,” Sri Widodo said.

Furthermore, Sri Widodo said that Lemhannas RI has a legal basis in implementing SPBE. This is stated in the Governor of Lemhannas RI’s Decree Number 125 of 2020 concerning Governance Policies and Service Policies of the Electronic-Based Government System of Lemhannas RI.

Sri Widodo said that the implementation of SPBE has started since the issuance of the Presidential Instruction No. 3 of 2003 concerning National Policies and Strategies for E-Government Development. According to him, currently, Lemhannas RI has built 30 application systems. This is a form of implementation in supporting the Government’s SPBE policy.

Meanwhile, Rahmat Gunawan as a speaker said that the results of the

SPBE were increasing budget efficiency for the development of Electronic-Based Government and increasing the infrastructure utilization of integrated Information and Communication Technology and sharing of uses by Government Agencies and Regional Governments. “There are several sharing applications, for example the JDIH application and the Information and Legal Data Network that are developed by Kominfo and distributed to all agencies,” Rahmat Gunawan said.

Furthermore, Rahmat said that the government’s web or application is still vulnerable to hacking. This makes the government’s web or application a target for the Information Security Practicum in the Information Security course because the web and application system are not maintained properly. Rahmat Gunawan take an example of the case of the leak of 279 million BPJS Health participants data which were sold on the Raid Forums website.

The former Kominfo consultant hopes that the government’s information system will be more secure. “The criteria of CIA can be considered safe. The criteria include guaranteed confidentiality, guaranteed data integrity, and accountability, namely the data used is clear (the user),” Rahmat Gunawan said. SPBE is Government Service and Public Service in nature. Government Services include e-Office, e-Planning, e-Budgeting, and e-Money, while Public Services include e-Pengaduan, e-Kesehatan, dan e-Pendidikan.
