Lemhannas RI carries out the national seminar with the theme **The Urgency of Regional Expansion For The Improvement Of Community Service & Welfare** which performed on August 29th, 2009. Prof. DR. Muladi, S.H., as the Governor of Lemhannas RI said that during the constant democratization process, in which one of its principle values that was unanimously agreed upon was the implementation of the Regional Autonomy program, the regional expansion had received the priority for review as on one hand it has strategic values as an effort to increase public service and welfare, but on the other hand it also raises some issues caused by partial perceptions that occur and is not yet comprehensive in interpreting the constitutions. Therefore no complete image has ever been made regarding the substance of regional expansion. It will impact on the performance being made so the decentralization policy had served as the right option as one of the manifestations for the forming of an autonomous region.

In accordance with the 1945 Constitutions, the purpose of granting autonomy to the regions was to quicken the realization of public welfare through improvement of community service, empowerment and involvement, those regions hoped to be able to improve competitive capabilities concerning to democracy principles, distribution, justice, and specialty, particularity along with potential and regional diversity within The Unitary State of Republic of Indonesia.

In the last decade, the expansion and establishing of autonomous regions has continued steadily. Since 1999 up to this day, 205 autonomous regions have been established, consists of 7 provinces, 164 regencies and 34 municipalities. Therefore the current total number of autonomous regions that have been established amount to 524 regions that consists of 33 provinces, 398 regencies and 93 municipalities.

Since the reformation, the regional expansion phenomena had occurred in public as if without control, therefore appearing as process of regional segregation being easily carried out which also appears as beneficial more for the political elites, therefore overseeing rational and constructive requirements. In this matter, the government, being responsible for carrying out the regional autonomy program faces difficulties in controlling the growth pace of regional expansion as it yet has a grand design regarding the ideal amount of autonomous regions in Indonesia along with other various constraints in implementing regional expansion evaluations, based on calculated parameters. Meanwhile at the same time a series of new proposals concerning regional expansion is being discussed by the Legislative Assembly.

Lemhannas RI, either as the national leadership education institution and the strategic studies and nationalism values consolidation center is always concerned with international indices, which can be used as a self introspection tool. The two international indices that more or less relates to the seminar's theme for reflection are:

1. The Democracy Index from the Economist Intelligence Unit Index that evaluates the conditions of 167 countries based on several parameters where one of them is the Functioning of Government. In 2008, from the four classified categories; Full Democracy, Flawed Democracy, Hybrid Regimes and Authoritarian Regimes, Indonesia along with 53 other countries categorized as the Flawed Democracy.

2. The Failed States Index from The Fund For Peace And The Magazine Foreign Policy, in which one of the indicators is the Progressive Deterioration of Public Service that produces four categories; Alert, Warning, Moderate and Sustainable. In 2008 Indonesia, from 177 countries, Indonesia along with 93 others was listed under the Warning category.

WHAT AND WHO OF THE LEMHANNAS RI Governing BOARD

Presidential Regulation Republic of Indonesia Number 67 of 2006, dated June 13rd, 2006 on National Resilience Institute of the Republic of Indonesia describes in the third section the Governing Board of Lemhannas RI. It is a challenge for Lemhannas RI to improve the posture and role in realizing the principal duties and functions of the institute in dealing with Globalization as well as other strategic environments. According to the Secretary of Governing Board, Maj. Gen. TNI (Ret.) Albert Inkiriwang, the transformation from National Defense Agency (Lemhannas) into National resilience Institute of the Republic of Indonesia (Lemhannas RI) constitutes that the full authority shall

be on the Government of Lemhannas RI. Governing Board of Lemhannas RI is a board having equal position to the Governor of Lemhannas RI. If compared to the organization at State University, then it is equal to the Board of Trustee and if compared to private corporation, it is equal to Board of Commissioner. Thereafter it is specifically described that Governing Board has the duty to formulate general policy of Lemhannas RI, and in performing such duty, then the Governing Board run the function of general policy formulation in the field of: education for cadre formatting and consolidation of national level leader; strategic review of various national and international issues; consolidation

of national values; post-graduate education cooperation in the field of national and/or international tenacity strategic study; as well as strategic review cooperation and cooperation of consolidating national values with both domestic and foreign institutions. Its management consists of 9 (nine) members with collective leadership comprising of one Coordinator and concurrently serving as a member, directly held by the Governor of Lemhannas RI, and a Secretary concurrently serving as a member, and 7 (seven) members. The complete description on Board of Advisor organization in this edition shall not describe the composition of members

in detail since it has been described in the earlier edition of News Letter (second edition).

In case that the Coordinator of Governing Board cannot serve its duty, then it can be represented by one of the selected members. Governing Board in running its program and activity is supported and facilitated by the Principal Secretary of Lemhannas RI. Designation of the criteria for Members of Governing Board in accordance with Presidential Regulation Number 67 of 2006 may originate in the bureaucrats, technocrats, experts/professionals, and/or community leaders. The prospective members of Governing Board is proposed to the President by Governor of Lemhannas RI at most twice as the amount of members of Governing Board and the management of members of Governing Board is designated by Presidential Decree, and their term of service is 4 (four) years and may be re-elected only for one subsequent term of service.

The activity program conducted by the Governing Board is in form of: Plenary Meeting held once in every 3 (three) months and at any time as necessary. Resolutions of the Governing Board is adopted in the Plenary Meeting presided over by the Coordinator of Governing Board and attended by the members of Governing Board, and only declared valid if attended by at least 5 (five) members.

The types of plenary meetings of the Governing Board are: 1. Quarterly Plenary Meeting to formulate and designate the function of general policy formulation of Lemhannas RI in accordance with the duties and functions of Governing Board of Lemhannas RI, 2. Special

Plenary Meeting to resolve a policy upon special assignment from the President of Republic of Indonesia, strategic environmental development highly influential to the national and local interest, as well as the territorial and global influence on the national interest.

Method of implementation:

1. Quarterly Plenary Meeting is held pursuant to principal activities, including:
 - a. Meeting/discussion on internal issues in the purpose of formulating the general policies formula of Lemhannas RI, discussion of and organizing official visit activity, discussion of and organizing one of the functions of Governing Board Lemhannas RI, by involving structural and functional selective officials of Lemhannas RI in the purpose of obtaining optimum result in executing duties and functions of Governing Board of Lemhannas RI.
 - b. Internal Meeting/Discussion of the Governing Board of Lemhannas RI is to formulate the general policy formula of Lemhannas RI, discussion of and organizing official visit activity, discussion of Lemhannas RI by involving the Structural and functional selective officials of Lemhannas RI.
2. Special Plenary Meeting is held by Special Meeting/Discussion in order to each strategic issue related to general policy of the Governing Board Lemhannas RI may be resolved professionally, proportionally and fair.

Both methods of meeting above is conducted comprehensively, integrally and holistically by putting forward priority scale.

Programs and activities of Assisting, Coordination, Monitoring and Evaluation by the Governing Board Lemhannas RI are carried out to create conducive situation, which is professional, proportional, clean and accountable as well as guided by precise address, on target to activity program applicable in the area of Lemhannas RI in the purpose of obtaining optimal result in implementing duties and functions of the Governing Board Lemhannas RI. The method of implementation in Assisting, coordination, Monitoring and Evaluation activities is performed comprehensively, integrally and holistically to the functions of the Governing Board, and regulated in 2 (two) kinds of Activities including Assisting and Evaluation. Specifically for Experts and Professionals, the activity is called Intellectual Exercise as well as individual activity of the members of Governing Board includes Coordination of and Monitoring to the education of cadre formatting and consolidation of national leaders, strategic review on various national and international issues, consolidation of national values, cooperation of post graduate education in the field of national tenacity strategic study with national and/or international educational institutions as well as cooperation of strategic review and cooperation of consolidating national values with domestic and foreign institutions.

LEADERSHIP FOR THE NEW ASEAN IN 21st CENTURY

having the duty of coordinating and managing the work of ASEAN; Second, Dialog of ASEAN Ambassadors, facility for Partners and neighboring countries in order to promote a closer involvement with International Society; Third, Development of dispute resolution mechanism based on ASEAN Community; Fourth, Organizing of ASEAN Inter-Governmental Commission for Human Rights at year end, and ASEAN Approval for Privilege and Immunity to facilitate ASEAN business by the officials and other people.

It is also described that the history records the ASEAN leadership for not only limited merely to leadership modus, but also a combination of nature, style, contingency, transformation and various leaderships approach depending on the issue, nation and personality involved.

In the future, ASEAN Charter and Roadmap toward ASEAN Community 2015 contains Blueprint of ASEAN Community as well as Second Work Plan of ASEAN Integration Initiative providing direction and efforts of ASEAN Community development. Charter of principles, norms and objectives of ASEAN shall have the function of current and future framework for ASEAN leaders in each level and sector in order to formulate ASEAN policy.

Secretary General of ASEAN in his greeting expressed his gratefulness to Prof. DR. Muladi, SH for the invitation to the discussion and congratulation to the publishing of Indonesian National Leadership Index (ILNI) to have the function as "GUIDEPOST" in evaluating leadership level at all sectors in Indonesia.

According to H.E. Pushpanathan, the Vice Secretary General of ASEAN, since the establishment of ASEAN on August 1967, there has been transformation to change the Regional and Global Setting. The world has become smaller by emerge of high technology,

As we know, the Information System of ICT is a very important means or tool on the implementation of basic function and duty, either to government or private institutions, in order to achieve efficiency and effectiveness. That's why Lemhannas RI at this moment is developing the application of Good Governance through Electronic Evaluation (E-Evaluation) System in its environment to produce speed and accuracy of information, as well as transparency in various fields according to the basic functions and duties of Chief Secretariat and Deputies. Application of that Electronic Evaluation begins in education field, such as in the Short Term Education Program (PPSA) and Regular Education Program (PPRA).

Development of Electronic Evaluation in the Lemhannas RI environment is expected to aid and facilitate human resources in conducting evaluation in the education field so they

would be able to obtain maximum result.

The E-Evaluation Development is expected to give the following results:

1. An Electronic Evaluation System that is able to support fast, accurate and transparent education program evaluation process;
2. Trained operator workers to operate Electronic Evaluation System;
3. Electronic Evaluation System to be well socialized to computer users.

E-Evaluation System is also expected to be able to improve the quality of the Lemhannas RI Teaching Experts; such as:

1. Information System Implementation Project Manager;
2. Information Management Expert;
3. Analyst System;
4. Database Designer and Database Administrator;
5. Programmer.

Benefits for the PPSA and PPRA Participants are as follows:

1. Participants are able to quickly obtain evaluation scores data;
2. Participants are able to know their scores transparently;
3. Participants are able to access evaluation scores data, at any time and any place;
4. Participants are able to obtain other information, for instance, class schedule, tutorial schedule, main activity schedule, et cetera.

Another benefit of the E-Evaluation development is: Improvement of the Institution's credibility and accountability.
