



STRENGTHENING OF NATIONAL VALUES FOR HEADS AND MEMBERS OF THE REGIONAL LEGISLATIVE COUNCILS AND REGIONAL GOVERNMENT OFFICIALS BATCH XXVIII OF LEMHANNAS RI

The Deputy for the Strengthening of National Values of Lemhannas RI holds the Strengthening of National Values for Heads and Members of the Regional Legislative Councils (DPRD) and Government Officials Batch XXVIII. The activity was held in cooperation between Lemhannas RI and ADEKSI, and was opened by the Governor of Lemhannas RI Prof. Dr. Ir. Prof. Budi Susilo Soepandji, D.E.A. on September 19, 2011 in Dwi Warna Purwa Building of Lemhannas RI. The strengthening of national values activity was held on the 3rd floor, East Wing of Pancagatra Building of Lemhannas RI for 5 days. It was filled with lectures, discussions, paper preparation and recommendation making. This activity was expected to increase the knowledge of the participants to better understand and realize the importance of national values for the continuity of the nation. An outbound activity was held at the end of the program in Paspampres Group C, Bogor, focusing on field activities and outdoor recreation and games (fun games). Another important activity was the simulation of decision-making process aimed at fostering a sense of togetherness and brotherhood among the participants.

The Domestic Strategic Study (SSDN) was one of the main activities that must be followed by the participants of the Regular Education Program (PPRA) Batch XLVI of Lemhannas RI that was designed to provide an opportunity for the participants to learn, understand and assess the potentials of the regions and various problems faced by the regions in terms of welfare and security.

From 19 to 23 September 2011, the participants of the PPRA XLVI of Lemhannas RI carried out the Domestic Strategic Study, which were divided into 5 groups to five provinces, namely: Bangka Belitung, South Kalimantan, Central Sulawesi, Bali and West Nusa Tenggara. In the SSDN, the participants of PPRA XLVI were accompanied by Expert Lecturers of Lemhannas RI. The SSDN activity was focused on the legal aspects in accordance with the themes of education and seminar of PPRA XLVI 2011, which was the “the Supremacy of Law within the Framework of National Resilience”.

The benefits of SSDN activities for the PPRA participants were to increase the knowledge and experience, as well as obtain data and information for strategic studies, especially in law enforcement and human resource development. In addition, the participants could also see firsthand the implementation of

development in the regions.

In the framework of the SSDN activities, the Governor of Lemhannas RI Prof. Dr. Ir. Budi Susilo Soepandji, D.E.A. as Patron I in the SSDN made a visit to three provinces, namely Bangka Belitung, South Kalimantan and Bali. The visit to the Province of Bangka Belitung lasted from 19 to 20 September 2011. The Governor of Lemhannas RI was received by the Governor of Bangka Belitung who was accompanied by the FKPD officials of the Province of Babel. Then, the Governor also made a visit to the Bangka Botanical Garden, PT. Timah Tbk., The College of Islamic Studies (STAIN) Shaykh Abdurrahman Siddik, reclamation location of former tin mining excavations in the Merawang area, religious tourism objects of Tionghoa ethnic, Kwan Yin Goddess Temple.

On 22 September 2011, the Governor of Lemhannas RI made a visit to South Kalimantan Province, and was welcomed by regional

government officials and FKPD of South Kalimantan Province. During the stay in the South Kalimantan Province, the Governor of Lemhannas RI made a working visit to PT. Pelindo III - Trisakti and the Office of South Kalimantan Governor.

The subsequent working visit

made by the Governor of Lemhannas RI was to Bali Province on Sep 22 – 25, 2011. The Governor of Lemhannas RI made a working visit to the University of Udayana, Regional Military Command IX - Udayana and tourism sites Garuda Wisnu Kencana in Tanjung Nusa Dua, Badung Regency, Bali.

In the framework of SSDN, the Vice Governor of Lemhannas RI Lt. Gen. Moeldoko, S.I.P. made an inspection to two provinces, namely Bali and Central Sulawesi. In the province of Bali, on 19 s.d. 20 September 2011, the Vice Governor of Lemhannas RI had a meeting with the Governor of Bali and the FKPD officials of the Bali Province in the governor's meeting room. It was then continued with interviews with local media.

Lemhannas RI organized a workshop on the Strengthening of National Resilience Measurement System and Public Policy Simulations on September 27, 2011 in Dwi Warna Purwa Building of Lemhannas RI. The event was opened by the Governor of Lemhannas RI Prof. Dr. Ir. Budi Susilo Soepandji, D.E.A., and was attended by the Vice Governor of Lemhannas RI, Secretary of the Governing Board, First Secretary, Deputies, Expert Lecturers, Expert Analysts, and Expert Professionals of Lemhannas RI. Also present were several representatives from ministries and Non-Ministerial Government Institutions, head of Regional Development Planning Board (Bappeda), Head of the Regional Statistics Agency (BPS), Chairman of LPPM from the Diponegoro University, University of North Sumatra, Cendrawasih University, Lambung Mangkurat University, and Hasanuddin University.

In this workshop, the National Resilience Measurement System and Public Policy Simulation (indicators, variables, and model for the variable linkage) as well as the data being used were updated. Given the rapid strategic environment,

the updating is done periodically in order to develop dynamic systems that require Time Series data.

The Governor of Lemhannas RI in his speech conveyed that currently we still face problems related to the relatively high unemployment, poverty and wealth inequality. Although the rates tend to decrease compared with a year earlier, those problems can still cause interference in our national resilience, both at the aggregate and provincial level. Therefore, the acceleration for the handling of those issues requires a synergy between policies and strategies, between the central and regional governments, as well as synergy among the regions. In this activity, identification and analysis of policies that need to be synergized will be made, so that the obstacles caused by the inappropriate policies and synergy can be eliminated.

Furthermore, the Governor of Lemhannas RI conveyed that with the carrying out of this activity, inputs and corrections from the participants were expected in order to perfect the system that has been built.

INTELLECTUAL EXERCISE OF THE GOVERNING BOARD OF LEMHANNAS RI

The Governing Board of Lemhannas RI held an Intellectual Exercise on September 30, 2011 on the 3rd Floor of West Wing, Astagatra Building, Lemhannas RI. The Governor of Lemhannas RI Prof. Dr. Ir. Budi Susilo Soepandji, D.E.A. as the coordinator of the Governing Board of Lemhannas RI, opened the intellectual exercise which was attended by the Vice Governor of Lemhannas RI, the Secretary and members of the Governing Board, First Secretary, Deputies, Expert Lecturers, Expert Analysts, and Expert Professionals.

closely related to security and order, which is a prerequisite for the implementation of national development. It will be impossible to create a stable national resilience if the public security and order are out of control. Therefore, the creation of stable and controllable public security and order must be supported by all components of the nation according to their respective duties and functions.

The Intellectual Exercise was held according to the formation of the composition of the Expert Lecturers, Expert Analysts and Expert Professionals. The presentations on the intellectual exercise were given by Expert Lecturer in the field of Science and Technology Maj. Gen. Kusworo, M.Sc. with the theme "Optimizing the Application of Science and Technology in Order to Support Alternative Energy Development Priorities within the Framework of National Resilience", which was followed then by Expert Analysts in the field of National Resilience Maj. Gen. I Gusti Putu Buana, with the theme "Improving the Roles of the Entire National Components in Maintaining Public Security and Order to Strengthen Stability within the Framework of National Resilience". The last presentation was given by Expert Professional in the field of economy Ario Wijanarko, S.H., MBA., M.Sc., with the theme "Improving Harmonious Relations between Companies and Workers in Order to Support a Conducive Investment Climate in the Framework of National Resilience".

PRE-SEMINAR ROUNDTABLE DISCUSSION OF PPRA XLVI OF LEMHANNAS RI

The National Seminar of the Regular Education Program (PPRA) Batch XLVI Year 2011 of Lemhannas RI is the peak activity of the education in Lemhannas RI. Therefore, in order to prepare themselves for the national seminar, the participants of PPRA XLVI organized a Roundtable Discussion with the theme “The Actualization of the Legal Culture in Order to Strengthen the Democratization in the Framework of National Resilience” on October 3, 2011 in Dwi Warna Purwa building of Lemhannas RI.

The roundtable discussion was organized by the participants of PPRA XLVI, and was opened by the Chairman of Seminar Consultancy Body Maj. Gen. Albiker Hutabarat, S.I.P., S.T., M.M. with resource persons including Prof. Dr. T. Gayus Lumbun, S.H., M.H. (Member of Commission II of DPR RI), who gave a presentation on “Post-Reform Legal Culture Actualization”. He described some of the agenda that he considered important in order to actualize the legal culture of Pancasila. First, the strengthening of the commitment to reinforce the national legal system; second, the strengthening of the judiciary body that is free from the pressures of power; and third, the establishment of legal

culture that puts corruption as a common enemy.

The next presentation was given by a lecturer from the University of Gajah Mada Prof. Dr. Irwan Abdullah with the topic “Revitalization of Indonesian culture in the Framework of Legal Culture Strengthening”. He conveyed that there are four root causes of violations of law; first, weak examples in legal affairs, second, widespread distrust in the legal process and decisions; third, shifting hegemony from the State to the media; fourth, rampant commodification of law. Furthermore, he also elaborated on the cultural potential in solving legal problems through four strategies; first, restructuring and refunctioning of cultural institution that encourages the strengthening of law; second, revamping of the legal and judicial systems that are transparent and are oriented to the public interest; third, empowerment of the state in upholding the supremacy of law over serious threats; fourth, legal accountability that requires legal disclosure in serving the needs of the public in legal issues.

With the presence of the two resource persons, the pre-seminar roundtable discussion is expected to be able to finalize the concept that will be discussed on the seminar at the end of the course.

RANK PROMOTION REPORTING OF THE MEMBERS OF LEMHANNAS RI

On October 3, 2011, the Head of General Affairs Bureau of the First Secretariat of Lemhannas RI received a reporting of rank promotion of the military and civil servant personnels at the Lobby of Astagatra building of Lemhannas RI. There is a total of 37 military and civil servant personnels who received a one-level higher rank promotion. The rank promotion is an award of State and Government of the Republic of Indonesia given to those who have met certain requirements.

In the career development system of the military and civil servant personnels, ranks are directly related to the positions entrusted to them. Therefore, any assignment of office, which it has been entrusted to any military and civil servant personnels, means an authority and responsibility that must be fulfilled in the best way possible. Even though the promotion is the right of every military and civil servant

personnel, it is more of a reward from the leaders to the personnels for their dedication and responsibility in carrying out job duties entrusted to them. Thus, this promotion carries moral consequences that must be more realized by any military and civil servant personnels regarding their obligations for the office tasks entrusted to them.

In his speech, the Head of General Affairs Bureau of the First Secretariat of the Lemhannas RI conveyed that with this rank promotion, the military and civil servant personnels are expected to further improve their performance and responsibility in accordance with the rank assigned to them by demonstrating outstanding achievement, dedication and loyalty. The rank promotion should give greater benefit to Lemhannas RI, especially for the nation and the Republic of Indonesia.

VERIFICATION BY NATIONAL BUREAUCRACY REFORM IMPLEMENTATION TECHNICAL TEAM (UPRBN) IN LEMHANNAS RI

The Governor of Lemhannas RI Prof. Dr. Ir. Budi Susilo Soepandji, D.E.A. received the National Bureaucracy Reform Implementation Technical Team (UPRBN) on October 5, 2011 in the governor's guest-room. The visit was made as part of field verification following the desk assessment desk for the Bureaucratic Reform of Lemhannas RI. Present at the occasion were the Secretary of the Advisory Board, Principal Secretary, The Deputy, Inspector, Director, and Head of the Bureau of National Resilience Institute of RI.

The UPRBN Team was chaired by the Deputy Assistant for Program Monitoring and Evaluation of the Ministry of Administrative Reform and Bureaucratic Reform Center Norman Jafar, and was accompanied by academics from the University of Indonesia. The purpose of the UPRBN team is to check the implementation of Bureaucratic Reform in Lemhannas RI, and later evaluate the feasibility of remuneration for Lemhannas RI.

The event was later continued in the Meeting Room Nusantara I with an opening speech from the Governor of Lemhannas RI. The Governor conveyed that the institutional reposition has been implemented since 2001, was continued with the revitalization of the institution in 2006

as stated in the Presidential Decree Number 67 of 2006. Over its journey, Lemhannas RI also has won numerous achievements, namely the unqualified opinion from the State Audit Agency (BPK) for four consecutive times for fiscal year 2007 to 2010, award for the Presentation of Financial Statements According to the Highest Standards of Government Accounting and Finance of the Ministry of Finance consecutively for state financial management from the fiscal year 2007 to 2010. It also ranked 15th out of 74 institutions in 2007, and CC rating consecutively from 2008 to 2010 for the Government Performance Accountability Report from the Ministry of State Apparatus Empowerment and Bureaucratic Reform, and ranked 2nd out of 167 ministries/institutions in Jakarta for the Preparation, Presentation and Management of State Property, and belonged the top 10 for the Level of the Use of Domestic Components from the Ministry of Home Affairs.

With all the Lemhannas RI's achievements and roles, the Governor of Lemhannas RI conveyed that all the employees of Lemhannas RI states have been ready to implement Bureaucratic Reform, and have a good working system even though there are some issues that still need improvement and suggestions from the UPRBN team.

SPECIAL DISCUSSION OF LEMHANNAS RI'S GOVERNING BOARD

The Governing Board of Lemhannas RI held a special discussion in the meeting room of the Governing Board on August 5, 2011 last. The Governor of Lemhannas RI Prof. Dr. Ir. Budi Susilo Soepandji, D.E.A., acted as the Coordinator of the Governing Board, led a discussion that was attended by members of the Governing Board, namely the Coordinating Minister for People's Welfare R. Agung Laksono, the Chairman of the Indonesian Chamber of Commerce Suryo Bambang Sulisto and Prof. Dr. Juwono Sudarsono. The meeting discussed some fundamental issues; first, Continuing Bureaucratic Reform and Revitalization of Lemhannas RI; second, Accelerating Lemhannas RI towards World Class Institution; third, the Conception of Stability in an Era of Democracy.

In the special discussion, the Governor of Lemhannas RI conveyed that the essence of the 11 principles of Lemhannas revitalization have been accommodated in the Presidential Regulation. 67 dated June 13, 2006 on Lemhannas RI. Given the condition and challenges of the future strategic environment dynamics, the 11 principles of Lemhannas RI revitalization need improvements which include vertical and horizontal synchronization of the regulations. In this case, the improvements can be made through institutional strengthening, procedure efficiency, human resources quality enhancement, efficient, effective and productive bureaucracy, and acceleration of Lemhannas RI towards a World Class Institution.

Remuneration/performance benefits was also discussed. In terms of Lemhannas RI's acceleration towards a World Class Institution, the Governor of Lemhannas RI described the three preparation made by Lemhannas, namely, physical infrastructure, non-physical readiness, and Key Performance Indicator (KIP).

Furthermore, the concept of stability in the democratic era was also discussing using the following approaches; first, Pancasila, the 1945 Constitution, the Unitary State of the Republic of Indonesia, the Unity in Diversity principle; second, accommodating global aspirations (the UN Charter); third, accommodating the aspirations of regional (ASEAN Charter); fourth, accommodating local wisdom and national culture; fifth, accommodating the demands and challenges of the strategic environment dynamics; sixth, accommodating aspirations of expertise (foundation, projection and contributing to the manifestation). Those six approaches must be fully supported by all the pillars of democracy, including the Executive, Legislative, Judiciary, and the Mass Media.

At the end of his presentation, the Governor of Lemhannas RI as the Coordinator of the Governing Board conveyed that the conception of stability in an era of democracy will be formulated and communicated with all national components, among others, through national seminars.

GOVERNOR'S AUDIENCE WITH YAYASAN JATI DIRI BANGSA
